



## AMENDMENT N°1 TO THE INTERNATIONAL JOINT SUPERVISION AGREEMENT FOR THE THESIS

### BETWEEN THE UNDERSIGNED:

The **UNIVERSITY OF ROUEN NORMANDY**, a public scientific, cultural and professional institution, whose registered office is located at 1, rue Thomas BECKET 76821 Mont Saint Aignan cedex, SIRET number: 197 619 042 00017, APE code 8542Z, represented by its President, Mr. Franck LE DERF, hereinafter referred to as "**URN** "

### AND

**L'UNIVERSITÀ DEGLI STUDI DI MESSINA**, an Italian public institution with registered office at Piazza Pugliatti 1, 98121, Messina, ITALY, tax identification number 80004070837 Hereinafter referred to as "**UNIME**" (host institution), represented by Professor Giovanna Spatari in his capacity as Rector

- The Parties have signed an International Joint Supervision Agreement (URN Ref: 012893), which took effect on 1 December 2024, concerning the preparation of the doctoral thesis of Ms Deniz ONAL. The undersigned wish to make amendments to the agreement and have therefore agreed to conclude this addendum. (hereinafter 'Addendum No. 1').

### WITH THIS IN MIND, THE UNDERSIGNED HAVE AGREED AS FOLLOWS:

#### Article 1 – AMENDMENTS

##### 1.1 Modification of Article 3 – RESEARCH PERIODS

The alternating periods of work in each INSTITUTION are distributed by the thesis directors according to the scientific requirements and the conditions of preparation of the thesis, and decided by mutual agreement, as follows:

- From 01/12/2024 to 31/05/2026 at the URN
- From 01/06/2026 to 30/11/2027 at UNIME

Amendment No. 1 will enter into force from the last date of signature by the Undersigned.

#### Article 3 – OTHER PROVISIONS

All articles and paragraphs of the Agreement which are not expressly amended by Amendment No. 1 remain unchanged, it being understood that Amendment No. 1 is an integral part of the Agreement and forms an indivisible whole with it.

#### Article 4 – DEMATERIALIZATION OF SIGNATURE

The Parties may sign Amendment No. 1 in electronic form by exchanging documents in PDF format or equivalent. It is expressly agreed that the document thus signed shall have the value of an original between the Undersigned, and shall be enforceable between them.


